**WORKSHEET PURPOSE:** A guide for personal use in preparing to make electronic applications. **KEY POINTS:** 

- Personal data generated from the AppState Banner System such as name, address, date of birth, email, phone number will flow directly from the Banner system, decreasing student input but becoming part of the application reviewed by the Admissions Committee.
- Application opens October 15<sup>th,</sup> allowing date to be entered and saved, but cannot be submitted until mid-December. Once the application has been submitted it cannot be retrieved or edited.

#### 2026 Application to the Bachelor of Science in Nursing Program

To be considered for admission to the BSN program, ALL students must meet the following requirements:

- Be admitted to AppState University (transfer students must be **accepted** to the university by December 15, 2025). Visit Undergraduate Admission page for admissions deadlines.
- Submit application online, **no later than January 12, 2026**. Applications in process not submitted by the deadline cannot be accepted.
- Be currently certified as a NC nursing assistant I required at the time of application.
- Submit official transcripts for **all colleges or universities attended** to the AppState Nursing Department no later than January 12, 2026. Only **official** transcripts will be accepted, meaning they must come directly from the university/ college electronically or by mail by the deadline date.
- Transcripts MUST INCLUDE:
  - o Should include the current year, fall semester grades.
  - o Should show courses that are "In Progress" for the upcoming spring semester.

#### REQUIREMENTS UPON NOTIFICATION OF PROVISIONAL ADMISSION

**Upon notification of provisional admission to the AppState BSN Program,** students will be required to submit the following by April 15th. Specific directions are provided in a BSN Information Session in early March via Zoom. This is outlined in the provisional admission to the program. See AppState Department of Nursing Handbook located on the program website under Student Information.

- 1. Physical and Safety and Technical Skills Evaluation.
- 2. Two-step tuberculosis testing.
- 3. Required immunizations and titers.
- 4. Criminal Background Check and Drug Screen.
- 5. Current certificate from the **American Heart Association** Healthcare Provider CPR course. (Card must be valid for a minimum of one year from the beginning of AppState BSN Program courses)
